#### PREVENTION, TREATMENT, CRISIS, RESOURCES

Mental Health and Recovery for Licking and Knox Counties is committed to meeting the board's statutory role as a local planning authority charged with responsibility for planning and implementing a system of behavioral health care services within Licking and Knox Counties. MHR's measurable statements provide the direction and operational focus needed to attain our areas of public policy focus and established outcomes

- Service Delivery System Plan the continuum of care that is determined by assessed needs, based on Recovery-Oriented System of Care principles, uses trauma-informed and culturally responsive best practices and leads to greater community health and wellness
- Sustainability Ensure long-term fiscal viability, demonstrates good stewardship of public dollars, and stabilizes the continuum of care
- System Workforce Recruit and retain a quality workforce
- Advocacy & Public Relations Provide advocacy and public education promoting equity, leading to greater awareness of recovery and resiliency, improved access to care, and reduced stigma

Our outcome-driven programs provide clear evidence that mental health and substance abuse funding in our communities benefit everyone.

## Programs That Assist People in Accessing Care

- 189 children and their families were served by the **Youth Mobile Crisis Team**. 100% avoided long-term out of home placement
- 5,687 calls were made to the **Pathways 211 Crisis Call Center**. 5389 adults & 298 youth benefited from crisis hotline services.
- 86% of the 6830 calls using Pathways 211 Information and Referral Services contacted at least one referral
- 898 people (age 12+) receiving immediate behavioral health services in **BHP's Care Now Urgent Care Clinics**. 99% received ongoing care in the community

## Programs that Support Recovery and Improve Mental Health

- 1,173 adults using substances received outpatient services. 77.5% reported improved functioning
- 69 youth using substances received outpatient services. 61% reported improved functioning
- 4,371 adults with mental health issues received outpatient services. 70% reported improved functioning
- 555 youth with mental health issues received outpatient services.
   65% reported improved functioning
- 62% of adults using peer support services reported a higher level of functioning.100% of people using family mentoring services reported they could effectively use community resources
- In Knox County, 650 naloxone kits were purchased with 258 people educated about infectious diseases and overdose prevention. Using SBIRT, 480 people were screened for potential SUD issues

## Programs that Address Health Disparities and Basic Needs

- 48 adults participated in the scattered site transitional housing program offering housing & supportive services. 95% exited the program and obtained housing
- 87% of the 226 adults using the Bridges Out of Poverty program reported higher levels of functioning with 79% retaining or increasing their employment or remaining in educational/vocational programs
- 94% of adults served in substance use disorder residential treatment programs and participating in the FAST Track Employment program retained their employment beyond 30 days
- 100% of people, 1069 served using domestic violence prevention, crisis, and advocacy services, and 91.5% using DV sheltering reported increased confidence and awareness in using community resources. DV shelters served 353 people including 104 children and 47 families
- 62 Addiction Treatment Program requests were made from special docket addiction courts for the basic needs of participants. Supports included short-term rent, assistance in paying utility bills, clothing needed for employment, and phone cards assisting adults in remaining successfully in recovery.


## Prevention Programs that Improve Health & Wellness

- 2,174 adults participated in parent education programs. 97% reported improvements in parenting skills & behaviors. 95% reported improved behaviors in their children
- 7700+ students received school-based services promoting substance abuse prevention, safe and healthy relationships, anti-bullying, problem-solving & conflict management, peer support & mentoring, and mental health and wellness.96% of students reported or demonstrated increased developmental competencies — skills and/or behaviors
- Almost 3000 people received suicide prevention education. 91% of students receiving Signs of Suicide education demonstrated an improved attitude about reaching out for help. 100% of adults participating in Mental Health First Aid or Gatekeeper Training reported an increased knowledge of how to effectively respond to a suicide crisis.
- Over 900 people from Licking County businesses, the chamber of commerce, schools and universities, and community, civic, and governmental groups received presentations promoting addressing mental health and wellness. 120 people attending the Knox County Communities Coming Together Conference.


